4.	To re-elect Mr Yang Zuo Ning as an executive director of the Company.		
5.	To re-elect Ms Wong Yuet Ming as an executive director of the Company.		
6.	To authorise the board of directors to fix the remuneration of the Directors for the year ending 31 December 2012. The bonuses in favour of the Directors shall be decided by the majority of the Board provided that the total amount of bonus payable to all the Directors in respect of any one financial year shall not exceed 10% of the consolidated profit after taxation of the Group for the relevant year.		
7.	To re-appoint Messrs. Deloitte Touche Tohmatsu as auditors for the ensuing year and to authorize the board of directors of the Company to fix their remuneration.		
8.	To grant a general mandate to the board of directors of the Company to allot, issue and deal with the Company's shares not exceeding 20% of the issued share capital of the Company, in terms as set out in ordinary resolution number 8 in the Notice.		
9.	To grant a general mandate to the board of directors of the Company to repurchase the Company's shares not exceeding 10% of the issued share capital of the Company, in terms as set out as ordinary resolution number 9 in the Notice.		
10.	To approve the extension of the general mandate to be granted to the board of directors of the Company to allot, issue and deal with the Company's shares by an amount not exceeding the amount of the Company's shares repurchased by the Company, in terms as set out as ordinary resolution number 10 in the Notice.

Any member entitled to attend and vote at the AGM is entitled to appoint another person as his proxy to attend and vote instead of him. A member who is the holder of two or more shares may appoint more than one proxy to represent him and vote on his behalf at the AGM. A proxy need not be a member of the Company. In addition, a proxy or proxies representing either a member who is an individual or a member which is a corporation shall be entitled to exercise the same powers on behalf of the member which he or they represent as such member could exercise. 6

Where there are joint registered holders of any share, any one of such joint holder may vote, either in person or by proxy, in respect of such share as if he were solely entitled thereto, but if more than one of such joint holders be present at the meeting, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the register of members of the coters of a deceased member in whose name any share stands shall be deemed joint holders thereof. 7.
