INTRODUCTION

The purpose of this circular is to provide you with information regarding resolutions to be proposed at the AGM to be held at Cherry, Second Floor, InterContinental Hong Kong, 18 Salisbury Road, Kowloon, Hong Kong, on 9 May 2016 at 11:30 a.m. which, upon approval, would enable the Company to, among other things:

- (a) repurchase Shares not exceeding 10% of the aggregate number of Shares in issue as at the date of passing such resolution;
- (b) issue new Shares not exceeding 20% of the number of Shares in issue on the date of passing such resolution;

- (c) add to the new issue mandate in (b) above those Shares repurchased by the Company pursuant to the Repurchase Mandate set out in (a) above;
- (d) re-elect certain Directors of the Company; and
- (e) appoint a new Director.

PROPOSED REPURCHASE MANDATE AND ISSUE MANDATE

At the AGM, it will be proposed, by way of ordinary resolutions, that the Directors be given general mandates to (i) repurchase Shares, the aggregate number of which does not exceed 10% of the number of the issued Shares as at the date of passing the ordinary resolution; and (ii) allot, issue or otherwise deal with Shares not exceeding 20% of the aggregate number of the issued Shares on the date of the passing of the ordinary resolution; (iii) add to the new issue mandate in (ii) above those Shares repurchased by the Company pursuant to the Repurchase Mandate described in (i) above, during the period from the date of the AGM up to the conclusion of the next following annual general meeting of the Company. In accordance with article 87 of the Articles, each of Ms. Wai Siu Kee and Mr. Wong Kai Tung, Tony will retire at the AGM and, being eligible, will each offer herself or himself for re-election. In addition, Professor Chan Albert Sun Chi is proposed to be appointed as Director.

This is an explanatory statement given to all Shareholders relating to a resolution to be proposed at the AGM authorizing the Repurchase Mandate.

This explanatory statement contains all reasonable information required pursuant to Rule 10.06(1)(b) of the Listing Rules which are set out as follows:

1. EXERCISE OF THE REPURCHASE MANDATE

As at the Latest Practicable Date, the issued ordinary share capital of the Company comprised 825,000,000 Shares.

Subject to the passing of the proposed resolution granting the Repurchase Mandate at the AGM and on the basis that no further Shares are issued or repurchased prior to the AGM nor outstanding options, if any, granted under the share option scheme being exercised, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 82,500,000 Shares.

2. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and Shareholders as a whole for the Directors to have a general authority from Shareholders to enable the Company to repurchase Shares in the market. Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and Shareholders as a whole. Such repurchases may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per share and will only be made when the Directors believe that such repurchases will benefit the Company and Shareholders as a whole.

3. FUNDING OF REPURCHASES

Any repurchases may only be effected out of funds of the Company legally available for the purposes in accordance with the Company's memorandum of association and articles of association and the applicable laws of the Cayman Islands. A listed company may not repurchase its own shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

It is presently proposed that any repurchase of Shares would be made out of capital (subject to the Companies Law), profits of the Company or out of the proceeds of a fresh issue of Shares made for the purpose and, in the case of any premium payable on such repurchase, from profits of the Company or from the Company's share premium account or out of capital (subject to the Companies Law).

The repurchase of Shares made out of capital will be conditional upon the fact that immediately following the date on which payment out of capital is proposed to be made, the Company shall be able to pay its debts as they fall due in the ordinary course of business.

4. STATUS OF REPURCHASED SHARES

The Listing Rules provide that the listing of all repurchased Shares is automatically cancelled and that the certificates for those Shares must be cancelled and destroyed. Under the law of the Cayman Islands, a company's repurchased shares shall be treated as cancelled and its issued share capital (but not the authorized share capital) will be reduced accordingly.

5. EFFECT OF EXERCISE OF THE REPURCHASE MANDATE

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited financial statements contained in the annual report for the year ended 31 December 2015) in the event that the Repurchase Mandate is exercised in full. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

6. DISCLOSURE OF INTERESTS

None of the Directors and, to the best of their knowledge, having made all reasonable enquiries, none of their respective Close Associates, have any present intention, if the Repurchase Mandate is exercised, to sell any Shares to the Company.

No core connected person (as defined in the Listing Rules) has notified the Company that he has a present intention to sell Shares to the Company if the Repurchase Mandate is exercised and neither has any of the connected persons undertaken not to sell his Shares to the Company in the event the Repurchase Mandate is exercised.

7. DIRECTORS' UNDERTAKING

The Directors have undertaken to the Stock Exchange that they will exercise the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

8. TAKEOVERS CODE CONSEQUENCES

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert, depending on the level of increase in the Shareholder's interests, may obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 and 32 of the Takeovers Code. The Directors are not aware of any consequences which could arise under the Takeovers Code as a consequence of any repurchases pursuant to the Repurchase Mandate.

As at the Latest Practicable Date, Fortune Star Tradings Ltd., which is the controlling Shareholder of the Company, held approximately 75% of the Shares. As at the Latest Practicable Date, the Directors are not aware of any consequences for Fortune Star Tradings Ltd. under the Takeovers Code as a result, solely, of the Directors exercising the Repurchase Mandate in full. However, if the Repurchase Mandate is exercised in full, the amount of Shares held by Fortune Star Tradings Ltd. will increase to approximately 83.33% and the amount of Shares held by the public will be reduced to less than 25% of the total issued share capital of the Company respectively. The Directors have no intention to repurchase Shares to such an extent which will result in the number of Shares held by the public being reduced to less than 25%.

9. SHARE PURCHASE MADE BY THE COMPANY

No repurchases of securities have been made by the Company in the previous six months, whether on the Stock Exchange or otherwise.

The details of the Directors who are required to retire at the AGM according to the Articles and who, being eligible, offer themselves for re-election at the AGM are as follows:

(1) Ms. Wai Siu Kee – Executive Director

Ms. Wai Siu Kee, aged 71, is the Chairman and Executive Director of the Group who joined the Group since its establishment in 1976. She is also the founder, chairman and chief executive officer of Lee & Man Handbags Holding Limited (Stock Code: 1488). Ms. Wai has more than 50 years of experience in the manufacturing industry. She is responsible for the development of corporate strategies, corporate planning and overall management of the Group and in particular the marketing and development of the business of the Group. Ms. Wai is the honorary permanent president of the Hong Kong Baptist University Foundation. Ms. Wai is the mother of Mr. Lee Man Yan, the executive Director of the Group who also held 45% shareholdings of Fortune Star Tradings Ltd., which is the controlling shareholder of the Company.

Ms. Wai entered into a service contract with the Company on 1 September 2014 for three years and which term shall continue thereafter unless and until terminated by either the Company or Ms. Wai giving to the other not less than three months' notice in writing or payment of salary in lieu of notice to terminate the service contract. Pursuant to the service contract with Ms. Wai, she is entitled to an annual remuneration of HK\$2,160,000 and a discretionary bonus to be decided by the majority of the Directors (with Ms. Wai abstaining from voting and not being counted in the quorum in respect of any resolution proposed to determine the amount payable to herself) provided that the total amount of bonus payable to all the Directors in respect of any one financial year shall not exceed 10% of the consolidated profit after taxation of the Group for the relevant year. Her remuneration was determined by the board of Directors by reference to the prevailing market rates, the Company's remuneration policy, her duties and responsibility within the Group and her expected contribution to the Group.

Save as disclosed above, Ms. Wai did not hold any directorships in other listed public companies in the last three years preceding the Latest Practicable Date. Other than that mentioned above, Ms. Wai does not have any relationship with any other Directors, senior management, substantial shareholders (as defined in the Listing Rules), or controlling shareholders (as defined in the Listing Rules) of the Company. As at the Latest Practicable Date, Ms. Wai does not have any interests in the securities of the Company within the meaning of Part XV of the SFO.

Saved as disclosed above, there is no information relating to Ms. Wai that is required to be disclosed pursuant to Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there is no other matter which needs to be brought to the attention of the Shareholders in respect of Ms. Wai's re-election.

(2) Mr Wong Kai Tung, Tony - Independent Non-Executive Director

Mr. Wong Kai Tung, Tony, aged 73, has been an Independent Non-executive Director of the Company since 2004. He has been a practicing lawyer in Hong Kong since 1968 and has also been admitted as a solicitor in England and Wales. He is currently a consultant at Messrs. Hastings & Co., Solicitors and Notaries. Mr. Wong is also an Independent Non-executive Director of Lee & Man Paper Manufacturing Limited (Stock Code: 2314) and has been so since 2003.

Pursuant to an appointment letter to be entered into with the Company, Mr. Wong's appointment shall be for a term of approximately one year commencing from 9 May 2016 upon conclusion of the AGM and ending at the next annual general meeting of the Company but, in any event, no later than 30 June 2017. The appointment may be terminated by either party giving at least three months' prior notice in writing. Pursuant to the appointment letter, Mr. Wong will be entitled to receive an annual remuneration of HK\$150,000. His remuneration was determined by the board of Directors by reference to the prevailing market rates, the Company's remuneration policy, his duties and responsibility within the Group and his expected contribution to the Group.

Mr. Wong Kai Tung, Tony has been appointed as an independent non-executive Director of the Company for more than twelve years. The Company has received from Mr. Wong confirmation of independence according to Rule 3.13 of the Listing Rules. Mr. Wong has not engaged in any executive management of the Group. Taking into consideration of his independent scope of work in the past years, the Directors consider Mr. Wong to be independent under the Listing Rules despite the fact that he has served the Company for more than twelve years. The Board believes that Mr. Wong's continued tenure will bring considerable stability to the Board and the Board has benefited greatly from the presence of Mr. Wong who has over time gained valuable insight into the Group.

Save as disclosed above, Mr. Wong did not hold any directorships in other listed public companies in the last three years preceding the Latest Practicable Date. Mr. Wong does not have any relationship with any other Directors, senior management, substantial shareholders (as defined in the Listing Rules), or controlling shareholders (as defined in the Listing Rules) of the Company. DETAILS OF DIRECTOR PROPOSED TO BE APPOINTED AT THE AGM

(1) Professor Chan Albert Sun Chi – Executive Director

Professor Chan Albert Sun Chi, aged 65, is a world-renowned organic chemist, Member of the Chinese Academy of Sciences, and Emeritus President and Vice-Chancellor of Hong Kong Baptist University. Professor Chan received his bachelor degree from International Christian University in Japan in 1975 and his MSc and PhD degrees from the University of Chicago respectively in 1976 and 1979. Upon graduation from the University of Chicago, he started an industrial career at the Monsanto Corporate Research Laboratories where he had worked for 13 years, rising through the ranks of Senior Research Chemist, Research Specialist, Senior Research Specialist and finally Monsanto Fellow. In 1992-1993 he taught at the National Taiwan University as a Visiting Expert. Since joining the Hong Kong Polytechnic University in 1994, Professor Chan had served as Chair Professor and Head of the Department of Applied Biology and Chemical Technology, Dean of the Faculty of Applied Science and Textiles, and Vice President (Research Development). He was the 4th President and Vice-Chancellor of Hong Kong Baptist University in 2010–2015. Professor Chan's research areas include the application of chiral catalysts in asymmetric syntheses and their industrial applications, development of pharmaceutical products and related processes, pharmaceutical and nutritional products based on Chinese medicines, new organic chemical process and their industrial applications, research and industrial applications of green sciences, novel material discovery and development, etc. Elected as Member of the Chinese Academy of Sciences in 2001, Professor Chan has received numerous prestigious awards including the National Natural Science Award of China (second class), Japan Society of Synthetic Chemistry Lectureship Award, the Japan Society for the Promotion of Science Invitation Fellowship, and was appointed as Justice of Peace by the Hong Kong Government of Special Administrative Region. Professor Chan has enjoyed a very distinguished academic career, with seven books and more than 500 SCI journal papers published, as well as more than 11,000 citations on publications. In addition, he has 30 US patents and numerous Chinese patents granted, two series of technologies transferred to major global corporations for commercial application, one permit granted for the human clinical trial of new drug, and commercialization of a major invention (this is a practical and commercially attractive technology for converting the ozone-depleting chemical carbon tetrachloride to commercially useful chloroform. This technology is already successfully commercialized in China by the Company, and has made positive contribution to the sustainable development of chloroform industry as well as environmental protection.)

Pursuant to a service contract to be entered into with the Company, Professor Chan's appointment shall be for a term of three years commencing from 9 May 2016 upon conclusion of the AGM and which term shall continue thereafter, unless and until terminated by either the Company or Professor Chan giving to the other not less than three months' notice in writing or payment of salary in lieu of notice to terminate the service contract. Pursuant to the service contract to be entered into with Professor Chan, he is entitled to an annual remuneration of HK\$5,000,000 and a discretionary bonus to be decided by the majority of the Directors (with Professor Chan abstaining from voting and not being counted in the quorum in respect of any resolution proposed to determine the

amount payable to himself) provided that the total amount of bonus payable to all the Directors in respect of any one financial year shall not exceed 10% of the consolidated profit after taxation of the Group for the relevant year.
